

KENTUCKY SEED IMPROVEMENT ASSOCIATION
REVISED FEE SCHEDULE EFFECTIVE, October 1, 2011

1. MEMBERSHIP FEES

- ◆ Regular Member - \$100.00 per year sent in with the first field applications in a calendar year. Only grower members can have fields inspected and have their company name printed on certification tags. Different locations of business under the same ownership must apply separately for membership.
- ◆ Conditioner Member - \$200.00 per year due by March 31st. Only approved conditioners can clean and tag certified seed. Only approved conditioners may order tags.
- ◆ Associate Member - \$50.00 per year. Associate members receive all mailings of a regular member, but are not actively producing or conditioning certified seed.
- ◆ Bulk Retailer - \$75 per year. Allows Certified seed sales, usually small grains, directly to farmers. Must issue a Bulk Sales Certificate with each sale. Due by September 1 each year.

2. FIELD INSPECTION FEES FOR CERTIFIED ACRES:

Small Grains and Soybeans	\$20.00	\$3.25
Corn	\$20.00	\$6.25
Tobacco	\$20.00 - first 1/4 acre or fraction thereof, plus \$14.00 for each additional 1/4 acre or fraction thereof for any one variety or any additional variety.

- Note:
1. Fees for certified or QA seed sold in bulk are the same as per unit tag and label fees.
 2. Royalties and special assessments on all varieties and classes of seed are made at the time tags and labels are billed.
 3. Sales of preprinted tobacco packets are due to KSIA by October 15.
 4. Unused pelleted tobacco tags can be returned for royalty credit by October 15.

5. Late Payment Fee - 2% interest past 30 days (with generally a grace month added during tobacco season)
