Pamela Obura recently became full time research analyst for Chris Shepard and Anthony Clark is reporting to Lauren Brzozowski. Jim Nelson is taking over Claire's chemical/lab safety responsibilities and Bill and Cam will temporarily take over the Soy Bean VT program and merge with their variety trial programs.

III. Budget

- a. This is the first year the PSS department has not experienced a significant cut
- b. There is still uncertainty on how the Dean will manage open faculty lines
- c. Departmental allowances/incentives will be released soon. Note that 12 programs overspent their allowances this year. This may be due to delay in Concur approvals from central campus or vendor price changes.

IV. Updates – General

- a. Undergrads
 - i. AES program recruited 7 new students this fall. Annual enrollment will need to double this to become a stand-alone degree program;
 - ii. 1st cohort of seniors in the program graduated in May;
 - iii. Certificate in Hemp Science is active.

b. Farm Updates

- i. North Farm (NF) Service Center was funded by motor pool and is currently understaffed so outlook remains uncertain
- ii. NF auction was successful selling 50 items for ~\$20K
- iii. NF mural is completed
- iv. UKREC has some temporary structures but the rebuild is very slow and frustrating
- v. UKREC irrigation/combine service has been dissolved

- vi. RCARS flood damaged buildings are scheduled for repair/renovation
